# **Australia**

Below are some useful links on the topic of Legal Studies. (DB) denotes Database.

#### Crime and Law enforcement websites

Parliament of Australia provides a guide to key internet links on crime and law enforcement.

#### Administrative Appeals Tribunal

The Administrative Appeals Tribunal (AAT) provides independent review of a wide range of administrative decisions made by the Australian Government and some non-government bodies. The AAT also reviews decisions of the Norfolk Island Government.

#### Administrative Law (Attorney-General's Department)

Administrative law is the body of law that regulates government decision making. Access to review of government decisions is a key component of access to justice.

#### AustLII (Australasian Legal Information Institute)

Key source of Australian legal information. (DB)

#### Federal Register of Legislation

The Federal Register of Legislation (the Legislation Register) is the authorised whole-of-government website for Commonwealth legislation and related documents. It contains the full text and details of the lifecycle of individual laws and the relationships between them.

#### High Court of Australia

The High Court is the highest court in the Australian judicial system.

#### JADE (Judgments and Decisions Enhanced)

Jade is a current awareness service that collects recent decisions of selected Australian Courts and Tribunals into an enhanced database. Although all basic Jade features are free, registration is required to use the customiseable options.

#### Lawcite

Lawcite is a freely available case citator service developed by Austlii. It is used to locate judgements, to find how a decision has been subsequently dealt with and to identify journal articles referring to the case.

#### Lawlex

Search all Australian legislation from one site. All principal legislation is categorised under the Lawlex subject index. This includes Acts, Bills, Regulations, Plans and By-laws. The subject index includes 29 categories with subcategories as relevant to those principal categories.

#### **Legal Database**

The Legal Database is a collection of legal and policy information. Here you have access to much of the material the Australian Tax Office uses when making decisions, including Legislation and supporting material, Public Rulings and Determinations, Case Decision Summaries (details of important decisions made by the ATO), ATO Practice Statements (directions to ATO staff on how to apply the laws administered by the Commissioner), Tax related case law.

#### Migration & Refugee Reviews

The Administrative Appeals Tribunal conducts merit reviews of visa and visa-related decisions made by the Australian Department of Immigration and Border Protection.

#### Northern Territory legislation

## **Queensland Judgments**

The object of the Queensland Judgments website is to publish, on behalf of the principal courts and tribunals of Queensland, an authoritative, complete and functional collection of Queensland case law (including the Queensland Reports) which can be made available to the community free of charge.

#### Queensland Legislation (Office of the Qld Parliamentary Counsel)

Provides fulltext access to Queensland legislation including Queensland Acts and Subordinate legislation as in force plus superseded reprints, Queensland Acts as passed, Subordinate legislation as made, Queensland Bills as well as Repealed legislation. (DB)

#### RefWorld

Refworld is the leading source of information necessary for taking quality decisions on refugee status. Includes foreign law legislation.

#### South Australia - Crime, justice and the law

#### Victoria Law & Justice

This database allows you to search for the meaning of abbreviations for legal publications, from the British Isles, the Commonwealth and the United States, including those covering international and comparative laws. (DB)

An international legal case and journal article citator. (DB)
